Honours & Awards Constitution

CHAPTER ONE

1. PREAMBLE

All awards made by St John's College require adherence to a system of credibility and transparency so that the integrity of these awards is ensured. It is vital, also, to follow a rigorous process to allow for consistency of awards over many generations in the College's history. To this end, the Honours and Awards Committee is formally appointed and constituted to carry out this important function. The structure of the Committee and the process of awards is detailed herein.

2. AUTHORITY

- 2.1 The Honours and Awards Committee of St John's College is authorised, in terms of the St John's Educational Trust Constitution, clause 2.4, to decide upon and grant awards and distinctions in the areas and disciplines listed under "Functions", clause 3. below.
- 2.2 The following proposals, subject to any amendments made by this Committee and approved by the Trustees, must be ratified at the beginning of each new calendar year.
- 2.3 All new awards need to be approved by the Board.
- 2.4 This Constitution, together with all minutes shall be kept in a separate book and made available to any member of staff on request.



3. COMPOSITION OF THE COMMITTEE

- 3.1 The Committee shall be composed of the following members:
- The Chairman: Deputy Headmaster, Student and Faculty Affairs.
- 3.3 The Secretary: appointed at the beginning of the year from within the Committee.
- 3.4 The Deputy Heads.
- The four House Heads and Directors of Sports and Cultural Activities.
- 3.6 Any member of staff who in the opinion of the Committee, could make a significant contribution to the Committee's discussions, and who may be co-opted, with full voting powers, for any period deemed necessary by the Committee. Such members could include 1st team coaches not included in the categories above.
- 3.7 All recommendations for awards made by the Committee are to be approved by the Headmaster.

4. FUNCTIONS OF THE COMMITTEE

- 4.1 The functions of the Honours and Awards Committee shall include:
- 4.2 The consideration of proposals to recommend the granting, withholding, or removal of:
 - 4.2.1 Team Awards
 - 4.2.2 Half Colours
 - 4 2 3 Full Colours
 - 4 2 4 Honours Awards
 - 4.2.5 The awarding of Trophies and Special Prizes at Awards Assemblies.



- 4.3 The consideration of proposals for major trophies awarded on Speech Night, as follows, in order of significance:
 - 4.3.1 Salver for Service
 - 4.3.2 The Tapiwanashe Ben Siyakwazi Memorial Trophy
 - 4.3.3 The Ryan Vickery Golden Ram Award
 - 4.3.4 The Craig Ralph Memorial Trophy
 - 4.3.5 The Garrs Charger Trophy
 - 4.3.6 Sportsman of the Year
 - 4.3.7 The GPA Valedictorian Award
 - 4.3.8 The Athene Cup for Cultural Person of the Year
 - 4.3.9 The St John's Cross Award
 - 4.3.10 The Dux of the College
- 4.4 Oversee the design and display of awards and insignia.
- 4.5 The ratification of:
 - 4.5.1 1st Team Captains
 - 4.5.2 Presidents of Societies
 - 4.5.3 Heads of Houses

5. QUORUM

A quorum shall consist of two-thirds of all eligible members, or the nearest number to the full Committee.

6. VOTING

- 6.1 All members present shall have one vote.
- 6.2 Members not present may not vote by proxy.



- 6.3 Members not present may not appoint deputies to vote in their place.
- 6.4 Decisions shall be made on a simple majority vote.
- 6.5 Constitutional amendments must have the approval of 75% of the eligible members of the Committee.

7. MEETINGS

- 7.1 Meetings shall be held at least once per term, or more frequently, if deemed necessary.
- 7.2 Notice of meetings are to appear in the termly calendar or be sent to members one week in advance by the Secretary.

8. RECORDS

The Secretary shall be responsible for:

- 8.1 Typing and keeping minutes of all meetings in a minute book.
- 8.2 Issuing copies of the minutes to all members.
- 8.3 Recording all awards issued in the Awards Book.

9. RESPONSIBILITIES OF MEMBERS

Members shall be:

- 9.1 Objective in their judgements.
- 9.2 Become familiar with the teams and clubs, and the pupils under consideration by watching as many fixtures and activities as possible (in particular home fixtures).



10. APPLICATION FOR COLOURS

- 10.1 Prospective candidates for Half/Full Colours are required to self-nominate in all disciplines by completing Addendum 2 and attaching the required documents.
- 10.2 The Chairman of the Colours Committee will determine and publish in the school calendar the due date for submitting completed Addendum 2 forms to T.I.Cs.
- 10.3 The candidate is to attach supporting documents and proof of achievements with the application form. Examples are:
 - 10.3.1 An official letter from the governing body/ association.
 - 10.3.2 Certificates/results.
 - 10.3.3 A copy of an official email listing results/ achievements.
- 10.4 The application form is to be submitted to the respective T.I.C who will in turn compile a list of the applicants/ nominees on Addendum 1 form for onward submission to the Directors of Sport and Cultural Activities together with the supporting documents.
- 10.5 After every Colours Committee meeting, if any nominations for Half/Full Colours have been rejected, the affected students will receive direct feedback from a member of the committee as assigned by the Chairman.
- 10.6 In the event of further concerns after the feedback session, a candidate can appeal to the Committee in writing within five days of receiving confirmation of a decision. The appeal must be sent via email to <u>colourscommittee@stjohns.co.zw</u>
- 10.7 Thereafter, the decision of the committee, and ultimately the Headmaster, will be final.



CHAPTER TWO

Awards Criteria

For any student to achieve an award they must ensure they have fulfilled the co-curricular requirements set out by the College and be seen to contribute fully to all aspects of the College.

11. TEAM AWARDS CONDITIONS

In general, the candidate must have:

- 11.1 Reached U17 age group and be in Form 4 and above.
- 11.2 Displayed a high standard of sportsmanship and general behaviour.
- 11.3 Not brought the College into disrepute, whether participating in the activity or not.
- 11.4 Participated continually in the activity subsequent to the award.
- 11.5 Shown a high level of dedication to the team or club.
- 11.6 Displayed loyalty and dedication to the College.

With regard to Sport, the candidate must have:

- 11.7 Recognition of regular representation of the College First Team:
- 11.8 Played and/or attended 70% of matches and practices during the season or year.
- If injured, ill, or unavoidably absent, played or attended 40%
 70% of matches and practices during the season or year.

With regard to Cultural Activities, Societies and Clubs, the candidate must have:

- 11.10 Met the requirements stipulated in 9.1. 9.6.
- 11.11 Participated actively, including inter-school participation, in the activity nominated.



- 11.12 Attended 70% of fixtures, meetings and practices during the season or year.
- 11.13 If injured, ill, or unavoidably absent, played or attended 40% 70% of matches and practices during the season or year.
 - * Academic Team Awards have been discontinued.

12. HALF COLOURS CONDITIONS

In general, the candidate must have:

- 12.1 Reached U17 age group and be in Form 4 and above.
- 12.2 Be eligible for, and have been awarded a Team Award, where applicable.
- 12.3 Satisfied all the conditions relevant to receiving a Team Award, but with greater emphasis on loyalty to the school and team.
- 12.4 Achieved a similar award, or one equal in standing, at another school.

With regard to sport, the candidate must have:

- 12.5 Selected to represent Mashonaland U18A or higher or selected to represent CHISZ U18A or higher.
- 12.6 Subject to 12.5 above, shown that they are "outstanding" in the context of the team, in relation to the strength of the team and their comparison to other schools and teams.

With regard to Cultural Activities, Societies or Clubs, the candidate must have:

- 12.7 Attained special recognition or received special mention from an independent source, i.e. an external adjudicator.
- 12.8 Subject to 12.7 above, shown an "outstanding" talent or aptitude for the nature of the activity and/or
- 12.9 Played a major role or contributed significantly to the success of the activity.



With regard to Academics, the Candidate must have:

- 12.10 Recorded 8 or more points at IGCSE in one sitting and in the first attempt only based on the following system:
 - \circ A* = 2 points
 - A = 1 point
- 12.11 Recorded 5 or more points at AS level in one sitting and in the first attempt based on the following system:
 - \circ A* = 3 points
 - A/a^ = 2 points
 - \circ B/b[^] = 1 point
- 12.12 Subject to 12.10 or 12.11, achieved outstanding performance at IGCSE and/or AS level at St John's College and have a sound academic record.

13. FULL COLOURS AWARD CONDITIONS

In general, the Candidate must have:

- 13.1 Reached U18 age group and be in Lower 6 and above.
- 13.2 Be eligible for, and have been awarded Half Colours, where applicable.
- 13.3 Satisfied all the conditions relevant to receiving a Team Award, and Half Colours, but with greater emphasis on loyalty to the school and team and on individual excellence.
- 13.4 Achieved a similar award, or one equal in standing, at another school.

With regard to sport, the Candidate must have:

- 13.5 Selected to represent the national U18A team or higher.
- 13.6 Selected to represent CHISZ U18A team or higher for two years cumulative since Form 4.
- 13.7 Subject to 13.5 and 13.6, have a satisfactory disciplinary record



13.8 In the case of Captain of the College First Team, the award of Full Colours may be made on the recommendation of the First Team Coach.

With regard to Cultural Activities, Societies or Clubs, the Candidate

- 13.9 Achieved or been awarded multiple Honours Awards by the National Institute of Allied Arts (N.I.A.A.) or have won or been placed very highly in competitions, festivals or tournaments which are of a national context.
- 13.10 Subject to 13.9, displayed or shown "outstanding" talent for the activity in question and been one of few to have achieved or displayed this level of ability.
- 13.11 Have an impeccable disciplinary record.

With regard to Academics, the Candidate must have:

- 13.12 Attained 12 points or more at IGCSE in one sitting and at the first attempt based on the following system:
 - A* = 2 points
 - A = 1 point
- 13.13 Recorded 7 or more points at AS level in one sitting and in the first attempt based on the following system:
 - \circ A* = 3 points
 - \circ A/a $^{\land}$ = 2 points
 - \circ B/b $^{\land}$ = 1 point
- 13.14 Achieved outstanding performance at IGCSE and/or AS level at St John's College and have a sound academic record.

14. HONOURS AWARDS CONDITIONS

14.1 Students who qualify for Full Colours in the same discipline twice shall be awarded Honours.



- 14.2 In case of CHISZ representation at 1st Team, U18 level or higher, Honours shall be awarded only in Upper 6 subject to satisfying clause 13.6.
- 14.3 Honours recipients shall have their name, the year and the discipline for which they receive their Honours awards inscribed on a board which will be displayed in the Hall.
- 14.4 Full Colours and Honours cannot be awarded in the same calendar year.

15. THREE FULL COLOURS

- 15.1 Holders of Full Colours in three different disciplines are entitled to wear a special "Three Colours Tie". The tie must first be presented at an Awards Assembly.
- 15.2 Names are/will be inscribed on a board to be displayed in the hall.

16. FIVE FULL COLOURS

- 16.1 Holders of Full Colours in any five different disciplines shall be awarded a framed acknowledgement of their Colours awards, inset with a white/gold lined Colours badge.
- 16.2 Holders of five Full Colours which range over the three disciplines of academics, culture and sport shall be awarded a special "Black Blazer" which shall be provided by the College, in addition to a framed acknowledgement of their Colours awards, inset with a black/gold lined Colours badge.
- 16.3 Names are/will be inscribed on a board to be displayed in the hall



17. MAJOR AWARDS

(In ascending order of prominence).

In the case of these awards, nominations from staff must be made on PAT, with two seconders, and include a written motivation for the consideration of the award

The Committee will make the final decision as to the recipient(s) of each award and recommend these to the Headmaster for final ratification ahead of Speech Night.

17.1 DA VINCI SPIRIT OF SERVICE

17.1.1 To be awarded to the student in the Upper 6 for his/ her/their commitment to tutoring many students from across the entire spectrum of the school, an award recognising his/her/their service to the spirit of the Da Vinci ethos.

17.2 THE ONORATI CUP FOR FORTITUDE

17.2.1 To be awarded to any student in Form 1 to Upper 6 who has shown inspirational courage and an indomitable spirit.

17.3 HEADMASTER'S AWARDS FOR RESPECT, INTEGRITY AND EMPATHY

17.3.1 To be awarded to any student in Form 1 to Upper 6 who best embody our Core Values.

17.4 SALVER FOR SERVICE TO THE COLLEGE

17.4.1 To be awarded to the student in Upper 6 who has displayed the highest level of unconditional service to the College.

17.5 THE TAPIWANASHE BEN SIYAKWAZI MEMORIAL TROPHY

17.5.1 To be awarded to the student in Upper 6 who has demonstrated the most commitment and endeavour



towards his academics, cultural activities, sporting pursuits or all three.

17.6 THE RYAN VICKERY GOLDEN RAM AWARD

17.6.1 To be awarded to the student in Upper 6 who has excelled across the three disciplines of academics, culture and sports. In other words, the best "All Rounder" at the College.

17.7 CRAIG RALPH MEMORIAL TROPHY

17.7.1 To be awarded to the student in Upper 6 who has played games with the most whole-hearted enthusiasm, enjoyment, determination, and the greatest sense of sportsmanship.

17.8 THE GARRS CHARGER TROPHY

- 17.8.1 To be awarded to the student in the Upper 6 who has shown outstanding qualities of honour, chivalry, and valour: in other words, whose gentlemanly conduct (in the true sense of the word) has distinguished him above his peers.
- 17.8.2 His name will be inscribed on a board in the Hall.

17.9 THE COURAGEOUS LEADERSHIP AWARD

17.9.1 To be awarded to the student in the Upper 6 who has embodied the spirit of valour through humble leadership defined by "service to others."

17.10 THE EAA COLLEGE VALEDICTORIAN

17.10.1 To be awarded to the student in the Upper 6 who has emerged with the highest overall EAA assessment rating at the conclusion of the October assessment period.



17.11 ATHENE CUP FOR CULTURAL PERSON OF THE YEAR

- 17.11.1 To be awarded on Speech Night to the student(s) in Upper 6 whose contribution to the cultural life of the College has been the most outstanding, and/ or to be awarded to the student in Upper 6 who has achieved, in cultural endeavours, distinctions or status, based on performance above that of the level set for Full Colours.
- 17.11.2 A comprehensive citation of the recipient's achievements and contribution is to be written and read out on Speech Night.

17.12 SPORTSMAN OF THE YEAR

- 17.12.1 To be awarded on Speech Day to the student(s) in Upper 6 whose overall achievements on the sporting field in either one or several disciplines have established him as the College's top sportsman.
- 17.12.2 A comprehensive citation of the recipient's achievements and contribution is to be written and read out on Speech Night.

17.13 THE ST JOHN'S CROSS AWARD

- 17.13.1 To be awarded to the student in Upper 6 who has achieved, in sporting or cultural endeavours, distinctions or status based on performance which is considered to be above that of the level set for Full Colours.
- 17.13.2 A comprehensive citation of the recipient's achievements and contribution is to be written and read out on Speech Night and his name inscribed on a board in the Hall.

17.14 THE DUX OF COLLEGE



- 17.14.1 To be awarded to the student of the previous year who attained the highest overall results in the November public examinations of Upper 6.
- 17.14.2 His name will be inscribed on a board in the hall.

CHAPTER THREE

Display of Awards and Insignia

18. SPECIFIC TIES

- 18.1 Ties specific to certain societies must be approved by the Committee.
- 18.2 Ties are only to be worn when that activity is being conducted, for functions run by that activity or on formal occasions.

18.3 PERMANENT TIES:

- 18.3.1 Specific ties may be worn permanently by members of the following:
 - 18.3.1.1 School Prefects
 - 18 3 1 2 Student Council Members
 - 18.3.1.3 Music Prefects
 - 18.3.1.4 Library Prefects
 - 18.3.1.5 Members of the Pipe Band
 - 18.3.1.6 Holders of Full Colours Awards
 - 18.3.1.7 Holders of the Three Colours Tie
 - 18.3.1.8 Honours Tie (Full Colours Re-Award)

 - 19.1.1 Must be in Form 4 and above.
 - 19.1.2 Minimum 3 meets for Athletics.
 - 19.1.3 Minimum 5 performances for Pipe Band A.
 - 19.1.4 Minimum 5 caps for the rest of the sports-codes.

20. 1ST TEAM CAPTAINS AND PRESIDENTS OF SOCIETIES

- 20.1 A badge with the College Ram and the name of the sport of society written above in bold type.
 - 20.1.1 Captain or President's Badge





21. TEAM AWARD

- 21.1 Cloth tab with activity embroidered in Black (Silver) block capitals, sewn on to blazer below top pocket.
 - 21.1.1 Team Award Tab



22. HALF COLOURS

- 22.1 Black/silver laurel leaves to be sewn immediately below badge on blazer pocket, followed underneath by sport or activity tab for which the award has been made.
 - 22.1.1 Half Colours Tab

23. FULL COLOURS

- 23.1 Cream blazer.
- 23.2 Cream badge on blazer pocket.
- 23.3 Cloth tab, green on cream, worn below the blazer top pocket.
 - 23.3.1 Full-Colours Tab

- 28.5 The recipient's name will be inscribed on the Honours Board.




30. THE DEPUTY HEADBOY

CHAPTER FOUR

Ratification of 1st Team Captains and Presidents

It is the duty of the Senior Management Committee of the College to meet and ratify all nominations for:

- 32.3 1st Team Captains.
- 32.4 Presidents of Societies.
- 32.5 Heads of Houses.
- 32.6 The nominees must meet the criteria that they:
 - 32.6.1 Have an impeccable disciplinary record.
 - 32.6.2 Will represent the College with grace, dignity, and honour.
 - 32.6.3 Will not bring the name of the College into disrepute.



33. NOTES

- 33.1 While team awards are automatic subject to participation, Half Colours, Full Colours, and the St John's Cross awards represent very high standards of achievement and should be awarded with discretion.
- 33.2 It must be very clearly noted that all awards can be withheld or retracted if circumstances warrant.
- 33.3 ALL awards are a privilege and not a right.

34. DEBATE

- 34.1 Team Awards
 - 34.1.1 As outlined by the constitution and in addition, the candidate must have debated in at least 5 friendly debates.
- 34.2 Half Colours
 - 34.2.1 The candidate must achieve 18 points overall, excluding online tournaments, cumulative since Form 4.
- 34.3 Full Colours
 - 34.3.1 The candidate must achieve 24 points overall, excluding online tournaments, cumulative since Form 4

35.2 Half Colours

35.2.1 The candidate must achieve 16 points overall, excluding online conferences, cumulative since Form 4

35.3 Full Colours

35.3.1 The candidate must achieve 24 points overall, excluding online conferences, cumulative since Form 4.

 - 36.1.1 As outlined in the constitution and in addition, the candidate is required to have participated in at least one music competition, either as an individual or as part of a group.
- 36.2 Half Colours
 - 36.2.1 The candidate must achieve 24 points overall, cumulative since Form 4.
- 36.3 Full Colours
 - 36.3.1 The candidate must achieve 32 points overall,
